We enjoyed a visit from 2 police officers (one of which was a former student) This will allow students to gain relationships and feel more comfortable around local police officers. Students were able to ask questions or voice concerns during a well attended after school opportunity.

Tomorrow, the Black Student Union will be hosting a viewing of the biopic 42 about the life of Jackie Robinson.

Also tomorrow, students will have an 11:30 dismissal and teachers will complete an online training from the state of Pennsylvania on school safety and security. Specific topics will include trauma informed approaches and situational awareness. We will also participate in a team building activity.
